- 1. For each space you wish to occupy, submit 2 separate checks: one for \$200 and a second for \$25. (If you are not selected for Main Street and assigned to another area your \$25 check will be returned.)
- 2. Include at least two photographs of your product and display area (even if you were on Main Street last year). Your photographs will be returned.

MAIN STREET FOOD BOOTH(S) (WATER IS PROVIDED)

- 1. Submit a single check for \$650
- 2. Include at least **one photograph** of your booth.

BROADWAY STREET/ DOLLES PARK (electricity is not provided)

1. For each space you wish to occupy, submit a single check for \$200.
