She also stated that setup will commence on Wednesday the 29th if anyone would like to help.

2021-2022 Audit:

Mrs. Farley informed the council the total cost of the 2021-2022 SBOA Audit was 26,645.66 for all funds. This included our federal audit as well.

OLD BUSINESS

County Roads / Foreclosure:

Mr. Nickloy is still waiting on the county attorney. No further update at this time.

Ball Diamonds:

Mr. Dixon has met with the baseball organization from Tipton that is interested in the ball diamonds. Dixon stated that the organization would like to do maintenance and preparation to the ball diamonds during the off season and make the lease period April – July so they would not have to carry full Liability Insurance. Contract negotiations are being done.

Technology Solutions Midwest:

Mr. Wells attended the meeting to answer any question concerning his agreement for 2024. He also told the Council his camera service has not been satisfactory, but he will complete the project. They also discussed the town email accounts. After Mr. Wells answered questions from the council and residents, they decided to table the 2024 agreement for further review.

PFAS and PFOA Testing:

Mr. Dixon brought up the decision made on suspending testing for forever chemicals at the last meeting. Dixon stated that Taft called him to clarify a few things about the testing. Mr. Dixon also conducted his own research through the EPA and IDEM. It was determined that the Town's system will have to be tested at some point by 2025. The council agreed to have a special meeting on Friday, December 1st to further discuss this issue.
