BOND: Mrs. Farley informed the Council we have received the \$546,000.00 from our BOND. She has paid 2 invoices for soft costs totaling \$35,460.00 and is expecting to pay another \$25,000.00. She has also reimbursed the water utility for the water tower painting in the amount of \$77,995.00. She has been trying to contact Indiana Landmarks to repay the \$200,000.00 loan for the purchase of the library.

After a short discussion concerning repayments of the BOND, Mrs. Farley will contact Mr. Brock for his guidance.

Trash Increase: Mrs. Farley informed the council that she has implemented the \$1.30 trash increase along with a \$7.00 extra cart fee. The council agreed it would be best to send letters to each resident informing them of this change.
