## **OLD BUSINESS**

**Ball Diamond:** Tipton Ball League has done some work, but they still have a lot to do. Before sending a letter from the attorney, Mr. Dixon and Mr. Johnson will meet at the ball diamond and look at what is adequate and what would need to be redone.

HCSD Contract: The Hamilton County Sheriff's Department presented the Council with a new annual contract in the amount of \$68,750.00. Mr. Nickloy was still concerned about the coverage the town was going to receive and paying them for what they are required to do by law. The council tabled it for further review. Former Hamilton County Sheriff and now State Police Superintendent Doug Carter attended the meeting to support the town in the endeavor to have police protection. He voiced his concern with the amount of the contract that has been brought to the council. He is willing to go before the Hamilton County Council to help resolve the issue. The Council appreciated his concern and would welcome his help.

Mr. Farley received an email from Arcadia Police Chief Todd Urick with information concerning contracting with them. The Council will review this information.

## **NEW BUSINESS**

**Resolution R-08-2024-01:** A Resolution of the Town of Atlanta Authorizing the Town Clerk to Make Payment from the Water and Sever Fund. Mr. Johnson made a motion to approve the resolution with Mr. Farley, Seconded.

**Reorganization:** Mr. Joe Cox, Cicero Councilmen and Jackson Township Trustee, Robyn Cook attended the meeting to discuss with the residents, a reorganization of the northern Hamilton County communities and Jackson Township. After a lengthy discussion concerning tax revenues, TIF district, annexation, school district, financial analysis and several other issues, along with several questions asked by the residents it was evident there are more concerns to be discussed. The Township will be sending out a survey to the towns and township residents to see what their concerns would be.

**Purchase agreement:** The Council received a Purchase Agreement from Hudson Plumer in the amount of \$28,000.00 for the property located at 130 Meridian Street. The Attorney and Council will review the agreement.
