NEW BUSINESS

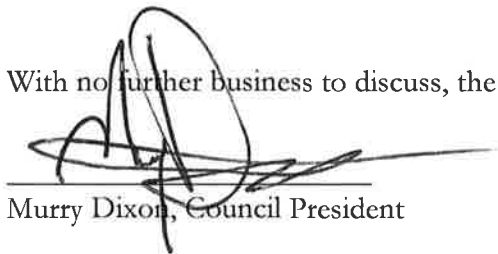
