OLD BUSINESS

Speed Limit Signs: Mr. Dixon would like clarification on the process of changing the town speed limits. Mr. Siebe will investigate this matter.

Ordinance 2025-03-01: An Ordinance of the Town of Atlanta, Indiana, Amending the Rates and Charges for the Waterworks and Sewage Works Utilities was introduced at the last meeting. Mrs. Farley will contact Mr. Brock concerning a Public Hearing and advertisement.

Library: The Council thought all color options for the inside of the lift would be acceptable, since this was the consensus, Mr. Dixon will pick the color.

Annexation: Mrs. Farley will look for the Contiguity and Fiscal Plan that Mr. Brock has put together for the town.

Ball Diamond: After a short discussion and review of appraisals, Mr. Johnson made a motion to put a for sale sign up with the asking price of \$450,000. Mrs. Van Hook, Seconded.

NEW BUSINESS

CCD Fund: Mrs. Farley informed the council about the Cumulative Capital Development Fund to help bring in more revenue for capital projects like sidewalks. This is tax based and time sensitive. We would need to move quickly, the deadline is May 31st, and a public hearing is needed. The Council will review this for the next meeting.

Resident Letter: Mr. Dixon composed a resident letter regarding the 400 block of Broadway St for festival. After the Council's review, it was decided to mail them out.

RDC Report/Meeting: RDC reporting is due April 15th. May 12th has been set for the next RDC meeting.
